

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [encoremovement.com](http://encoremovement.com), and Encore Movement and Physical Therapy and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Encore Movement and Physical Therapy include [encoremovement.com](http://encoremovement.com). The Encore Movement and Physical Therapy website is a health and wellness services site. By using the Encore Movement and Physical Therapy website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Encore Movement and Physical Therapy may collect personally identifiable information, such as your:
